Historic Operating Deficiencies

- No fee for Limitless Curbside Pickup. Consolidation of friends and neighbors.
- No fee charged for Recycling. Direct Expense \$87 per ton
- No fee charged for extraordinary large item pickups, i.e., refrigerators, bed frames, furniture, etc.

Conclusions:

The Town provides limitless trash and recycling services in spite of the fact that it does not own and operate a state of the art Transfer Facility.

The Town has historically underfunded solid waste services resulting in long-term structural deficits.

Where do we go from here?

- Take input and recommendations from the Citizens of Stoughton on Thursday, April 13, 2023.
- Prepare and present staff recommendations to the Select Board for rate and operational adjustments on May 2, 2023.
- Vote series of recommendations which will authorize rate and operational adjustments.
- Communicate changes to the Solid Waste program through various media outlets.
- Amend FY24 Solid Waste Budget expectations.
- Consider converting this Business Unit to an Enterprise Fund.
- Feasibility study of a Stoughton Transfer/Recycling Facility.
