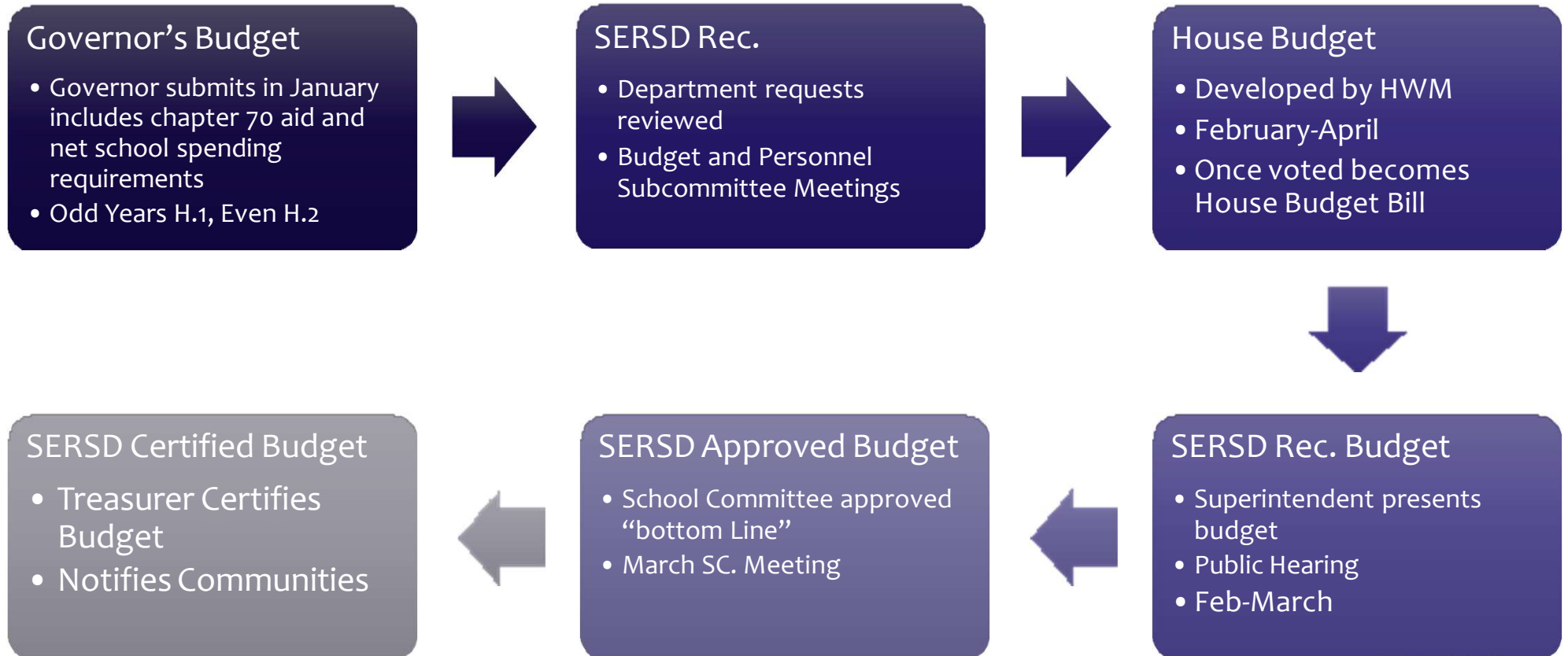

Regional School District Budget Process - continued

Senate Budget

- House Bill Passed to Senate Ways and Means
- Once Voted, becomes Senate Budget Bill



SERSD Adopted Budget

- March - June
- Meet with Finance Committees, BOS, Town Meetings, City Council
- Requires 2/3 Vote



Conference Committee

- House and Senate assign joint conference committee and debate budget until approved by both sides



Final Budget

- Also known as the General Appropriations Act
- June-July



SERSD Line Item Authority

- School Committee is able to approve and/ or make line items adjustments to the budget as long as they do not change the "bottom line"



Governor Veto Auth.

- 10 days to review and approve
- Can make line item vetoes
- House and Senate may override by 2/3 majority

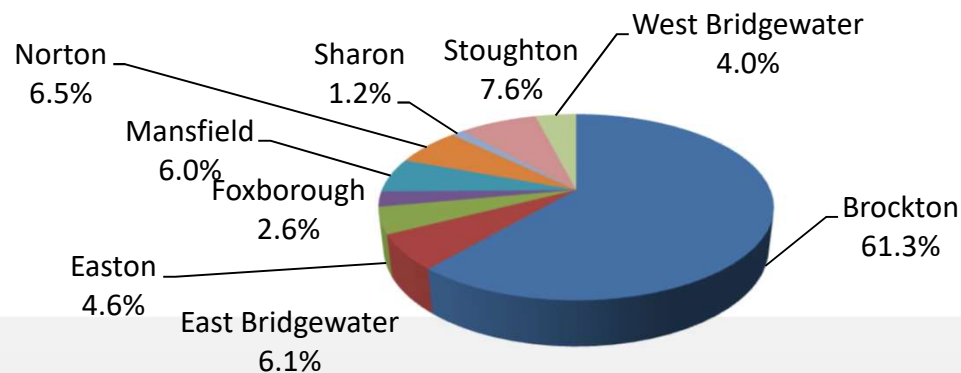
SERSD Budget Highlights

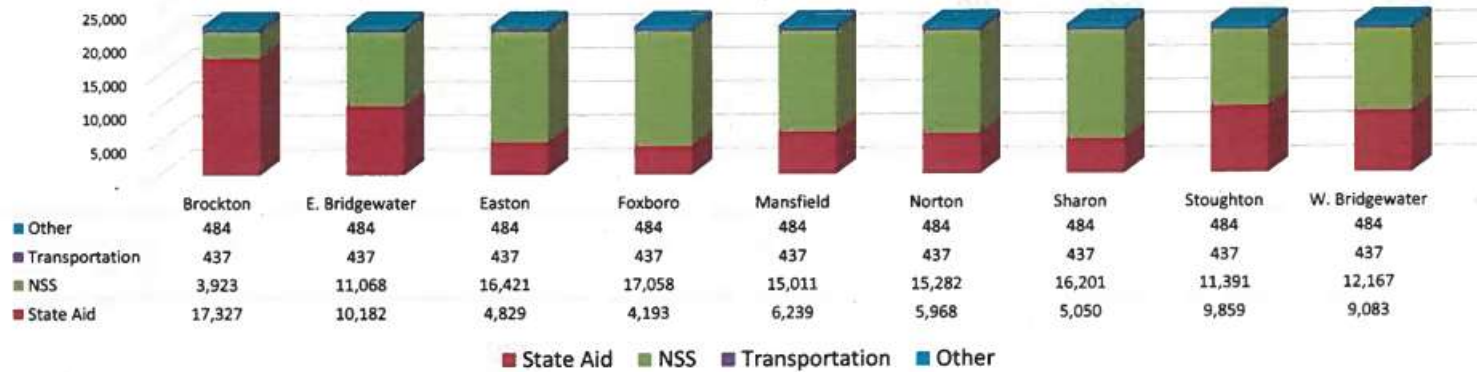

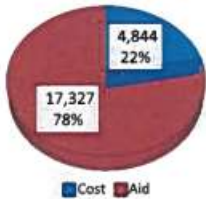

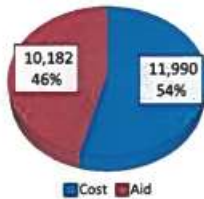
Per Pupil Costs By Community



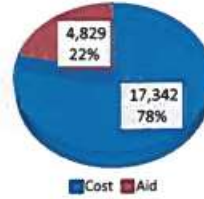
