Pursuant to the Warrant and the Constable's Return thereon, a Presidential Election was held at:

- Precinct 1 - Joseph R. Dawe, Jr. Elementary School, 131 Pine Street
- Precinct 2 - E.A. Jones Elementary School, 137 Walnut Street
- Precinct 3 - South Elementary School, 171 Ash Street
- Precinct 4 - Joseph H. Gibbons Elementary School, 235 Morton Street
- Precinct 5 - Joseph H. Gibbons Elementary School, 235 Morton Street
- Precinct 6 - Helen H. Hansen Elementary School, 1800 Central Street
- Precinct 7 - Richard L. Wilkins Elementary - (formerly West Elementary), 1322 Central Street
- Precinct 8 - Robert G. O'Donnell Middle School, 211 Cushing Street

The Warrant was partially read by the Precinct Wardens, when on motion of Precinct Clerks, it was voted to dispense with further reading of the Warrant, except the Constable's Return, which was then read by the Precinct Warden. The ballot boxes were examined by the respective Wardens and Police Officers on duty and each found to be empty and registered 00.
